# CHANGING MINDS REPORT AND GOOD PRACTICE GUIDELINES LAUNCHED


We launched an influential new report urging employers in Scotland to adopt 'Good Practice Guidelines' to tackle the under-representation of people of black and ethnic minority (BME) origin in the workforce.


The report, 'Changing Minds: Attitudes to BME Employment', found widespread under-representation of people of BME origin across Scottish housing associations. It also recommended 10 'Good Practice Guidelines' to bring about positive change.

The report was produced following a series of Job Fairs for BME people held in Scotland's major cities from 2004 to 2007 and organised by Trust, Bield and Hanover Housing Associations, in partnership with the Chartered Institute of Housing (CIH) and the Scottish Federation of Housing Associations (SFHA).

The 10 'Good Practice Guidelines' include advice on challenging stereotypes, introducing cultural awareness training, and ensuring the process for shortlisting job candidates is fair and transparent.


This has been done by letter, sending multilingual information on the project, followed by presentations/meetings to market the project.

## **Job Opportunities Support Project**

This Job Opportunities Support Project continues to be beneficial for individuals from BME communities seeking job opportunities or a career in Housing or the Public sector in Edinburgh and Lothians.

It is supporting individuals applying for jobs, directing them to further training or courses if needed to get into the employment market and referring them to other services available to help them. To date 259 people have been assessed and 23 of them have secured jobs.

# Positive Discrimination in favour of women, ethnic minorities and age

Equalities minister Harriet Harman has announced plans to allow positive discrimination to help organisations reflect the communities they serve by recruiting more female, ethnic minorities and ban age discrimination.

The plans will be adopted first across England followed by Wales and Scotland.

The minister said the proposed bill, which is due later this year would "Address the serious inequalities that still exist" in the UK.

We will keep you informed on how the bill progresses in the next issue of the newsletter.





The Common Housing Register housing application form jointly developed by Trust, Hanover (Scotland) and Bield Housing Associations will be available on the three Association's public website in the near future.

The translated version of the form will be available on the EqualityScotland website. We will continue to update you on the progress on this.

All three associations remain committed to providing advice and support to individuals with a language barrier in applying for housing by assisting in completing application forms and with benefit checks.



#### The Scottish Government Central Heating Programme

The Scottish Cabinet Secretary for Health and Wellbeing, Nicola Sturgeon announcement put the fuel poor at the heart of the Central Heating Programme. For this to develop the Central Heating and Warm Deal Programmes will be examined with proposals in autumn 2008.

As a result, applications for the remainder of the year will be prioritised to give central heating to those most at risk of fuel poverty.

From 22nd May 2008 the central heating programme will be available to those pensioners aged over 60 years of age who:

- Do not have a central heating
- Have a central heating system which is broken down and the applicant or partner is over 80 years of age
- Have a central heating system which is broken down and the applicant or partner is in receipt of the guaranteed element of Pension Credit.

The change does not affect applicants who applied before 22 May 2008.

This decision will be reviewed once the Fuel Poverty Forum provides its proposals and Ministers have considered them.
