HAPPY TO TRANSLATE LOGO FUNDING

HOUSING ASSOCIATIONS RECEIVE £132,000 GRANT FUNDING FROM SCOTTISH EXECUTIVE AND COMMUNITIES SCOTLAND FOR "HAPPY TO TRANSLATE" LOGO

Trust, Hanover (Scotland) and Bield Housing Associations have received grant funding from the Scotlish Executive and Communities Scotland for the "HAPPY TO TRANSLATE" LOGO PROJECT. The Logo will be a key tool in providing Black and Minority Ethnic (BME) communities with equal access to information and services, as required by the Race Relations (Amendment) Act 2000.

Service providers will use the Logo on their literature and in reception areas to help overcome language barriers BMEs may face when trying to access the service. The Logo means that service providers will assist by providing good quality translation and interpretation services. It is expected that members of BME communities will benefit from enhanced social inclusion when providers honour their "right to understand."

The Associations are delighted by the support of the Scottish Executive and Communities Scotland in developing this project, and the Logo will be an integral part of their strategic commitment to develop better communication between service providers and BME communities.

Minister for Communities, Margaret Curran, adds, "The Scottish Executive is committed to promoting the provision of high quality translating, interpreting and communication support services in order to ensure equality of access to public services for all those that might otherwise be disadvantaged or discriminated against. This is central to our promotion of race equality, our tackling of racism and our commitment to equality for disabled people. This project will have a valuable role in this process and we are therefore delighted to be supporting it."

A Steering Committee has been established made up of representatives from the funding bodies and pilot organisations to oversee the development and progress of the project. Development and implementation will occur in four distinct phases over the next three years:

Phase I	Develop and finalise Logo design; develop operational standards, guidelines
	and procedures to support the use of the Logo; establish Steering Committee.

Phase IIDesign pilot programme, including operational self-assessment procedures; map out launches and marketing campaigns.

Phase IIILaunch and pilot the Logo with five organisations (City of Edinburgh Council, Moray Council, and the 3 Associations), and monitor and assess use through

evaluation framework.

Phase IV Pending approval, roll-out and promote the use of the Logo as a fully operational project with service providers throughout Scotland.

Trust, Hanover (Scotland) and Bield Housing Associations have appointed a senior project manager to develop and launch the "Happy to Translate" Logo device to help members of Scotland's Black and Minority Ethnic (BME) communities achieve improved access to information and services.

Tamiko Mackie brings an impressive portfolio of skills and experience to the new post, which the three Associations believe will give the Logo project considerable integrity and impact and deliver tangible results.

In 1990, Tamiko began her career in Hollywood at Walt Disney Pictures & Television, and then was the vice-president of a US/British independent film and television company for seven years. In 1999, she founded a music man-

agement and consulting agency specialising in international artist management and bookings, publicity and marketing, and event planning. During this tenure she produced events at the annual Winter Music Conference in Miami, and consulted for events such as the Official GRAMMY Awards Party in 2000 and 2001.

Says Tamiko: "I am enthusiastic about the "Happy to Translate" Logo Project, and encouraged by the commitment of the Scotlish Executive and Communities Scotland, as well as the interest expressed by numerous organisations who would like to adopt the Logo. With BMEs accounting for just over 2% of Scotland's population, this country has a unique opportunity to proactively address challenges to equality and inclusion. It is crucial that good practices are established quickly nationwide to rectify inequalities. I believe the "Happy to Translate" Logo will be a powerful tool and symbol. This is a highly innovative and challenging project and I feel privileged to be a part of it."




The event was a great success with lively attendance of nearly 300. The Associations are looking forward to co-organising next year's event in Glasgow.
